



## Consent Form for disclosure of student personal information to **ASPIRATIONS4KIDS IN SPORT LIMITED (A4K)**

### Privacy Statement

The Department of Education (DoE) is collecting the personal information requested in this form in order to obtain lawful consent to disclose your child's and your personal information to A4K for the purposes of the A4K in Sports Grant Program (the Program). The information collected on this form will be dealt with in accordance with the confidentiality requirements of s.426 of the Education (General Provisions) Act 2006 (Qld) and the Information Privacy Act 2009 (Qld). The information will not otherwise be disclosed to any other person or agency unless it is for a purpose stated above, the disclosure is authorised or required by law, or you have given DoE permission for the information to be disclosed. ### Section 1 - A4K in Sports grant program

Aspirations4Kids in Sport Limited (A4K), an Australian Public Company limited by Guarantee (ACN 154 014 150) (<https://www.aspirations4kidsinsport.com.au/about-us/our-story/>) delivers a Sports Grants Program (Program) across Queensland to support Queensland students aged 10-19 years old participating in the Department of Education's (DoE) representative school sport program (Queensland School Sport). The Program provides grants to school students experiencing Financial Hardship, Chronic Illness, Remote Living Issues and student athletes with Disability to participate in QSS. Applications for A4K funding must be made by schools on behalf of students/parents/carers who have been identified by their school as potentially meeting the criteria for a grant. Please note that completing this form does not guarantee that the school will make an application to A4K on your behalf. The decision to make an application is at the school's discretion. A4K makes the final determination on applications for financial assistance. *Please Note: A4K is not part of DoE and DoE has no control over the operations of A4K. A4K is solely responsible for deciding applications for financial assistance and the delivery of the Program. A4K staff are not employed by DoE.*

**Financial hardship grant application – this funding assists students who are suffering from current impactful financial distress.**

- the family *must* hold a current low income health care, concession card or foster health care card and provide a copy to the school to provide to A4K to support the application; and  
- the application must demonstrate that the family of the nominee is facing financial distress through extenuating circumstances of current financial barriers that directly impact on the student's participation in the QSS sport event. The nominee must demonstrate a high standard of behaviour and attendance at school and an ongoing commitment to regular training and participation in sport.  
Documentary evidence may be attached to support the application. Any information attached will be provided to A4K.

- *the application must demonstrate that the family of the nominee is suffering from impactful financial hardship due to the remoteness of their residential address that directly impact on the student's participation in the QSS sport event.*

*The nominee must demonstrate a high standard of behaviour and attendance at school and an ongoing commitment to regular training and participation in sport.*

*Documentary evidence may be attached to support the application. Any information attached will be provided to A4K.*

- the application must demonstrate how this impacts directly on the nominee's capacity to participate in QSS.*

*The nominee must demonstrate a high standard of behaviour and attendance at school and an ongoing commitment to regular training and participation in sport.*

*Documentary evidence may be attached to support the application. Any information attached will be provided to A4K.*

**Hand up grant application** – *this funding assists students who do not qualify for financial hardship funding but due to a current, exceptional and unexpected circumstance, need short-term financial assistance.*

- evidence of extenuating, current short-term and highly impactful circumstances that have caused temporary financial difficulty; and*
- that the family of the nominee is facing financial distress that directly impact on the student's participation in the QSS sport event.*

*The nominee must demonstrate a high standard of behaviour and attendance at school and an ongoing commitment to regular training and participation in sport.*

*Documentary evidence may be attached to support the application. Any information attached will be provided to A4K.*
